



INSTRUCTIONS FOR USE
Pro-Ject Stereo Box E

Dear music lover,

thank you for purchasing an integrated amplifier from Pro-Ject Audio Systems.

In order to achieve maximum performance and reliability you should study these instructions for use carefully.



Warning of a hazard for the user, the unit or possible misuse.



Important notice.

Safety instructions

AC outlet voltages vary from country to country. Before connecting to the mains, make sure that the voltage in your area meets the voltage requirements printed on the power supply.

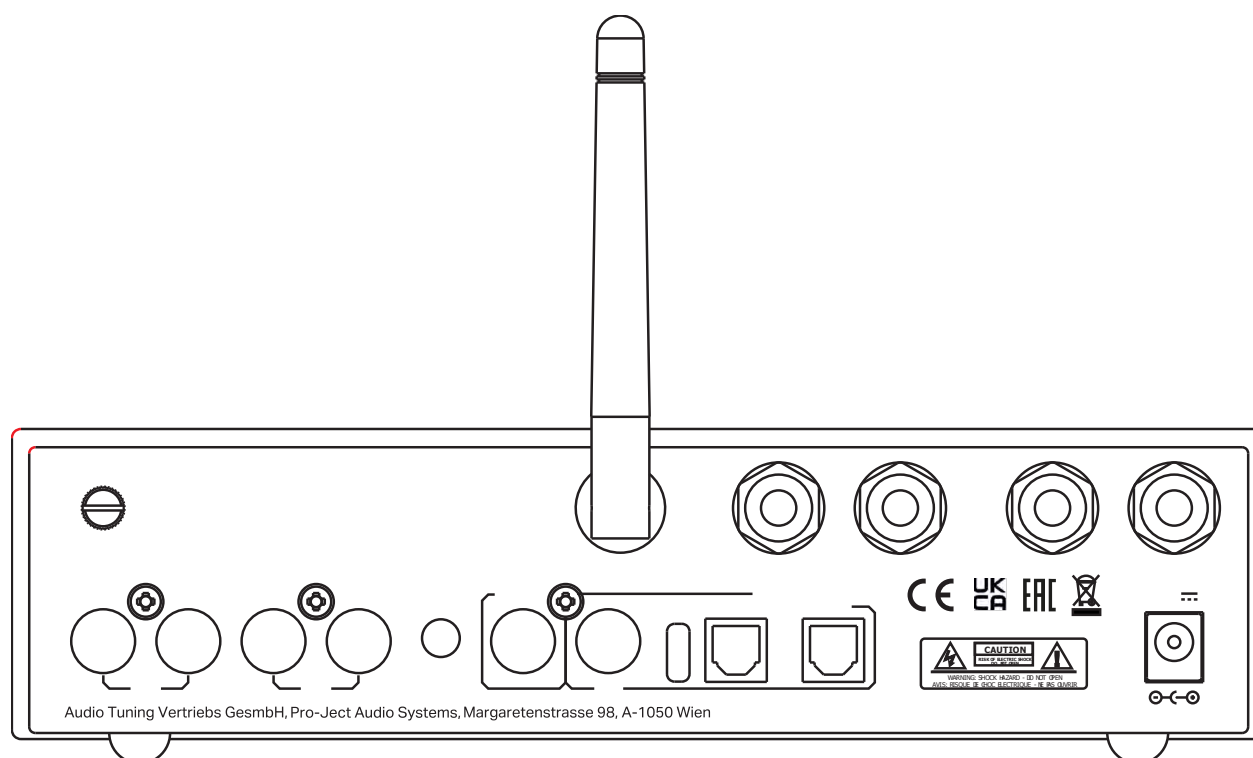


The power supply is used to disconnect the unit from the mains. Make sure that the power supply is easily accessible at all times. Never handle the device, the power supply while your hands are wet or damp.

Avoid letting liquids enter the device or the power supply. Never place any item containing liquid, such as a flower vase on or near the device. Never spill any liquid on the device or the power supply.

Never place any naked flame sources, such as lighted candles on or near the device. The product shall not be used in damp or wet locations, next to a bathtub, sink, swimming pool or any other similar conditions.

Connectors



Make all connections whilst the amplifier is disconnected from the power supply.

Take care to connect the left and right channels correctly. The right channel is usually marked red, the left channel black or white.

Never use any other power supply than the one supplied with the unit.

Phono input

Connect the tonearm signal lead to the **In 1 Phono** of the amplifier. The earthing wire may be connected to the screw terminal if you encounter hum problems when using the turntable. The phono input is suitable for MM and High-Output MC cartridges.

Line inputs

Line level sources (e.g. CD player, radio or TV) can be connected to the RCA input marked **In 2** and 3,5mm TRS input marked **In 3**.

Digital inputs

Sources with a digital output such as TV satellite/cable receiver or a game console can be connected to the digital inputs. Coaxial to **In 4** and optical to **In 5** and **In 6**.

Sub out

An active subwoofer can be connected to the output sockets marked **Sub out**.

Connection to the speakers

The output terminals accept loudspeaker cables terminated with 4mm Ø Banana plugs, spades connectors or naked wire.

USB 5V/1A output

The USB C output on the back can be used to supply modern streaming devices (for example a Stream Box S2, or many other manufacturer's devices) with power.

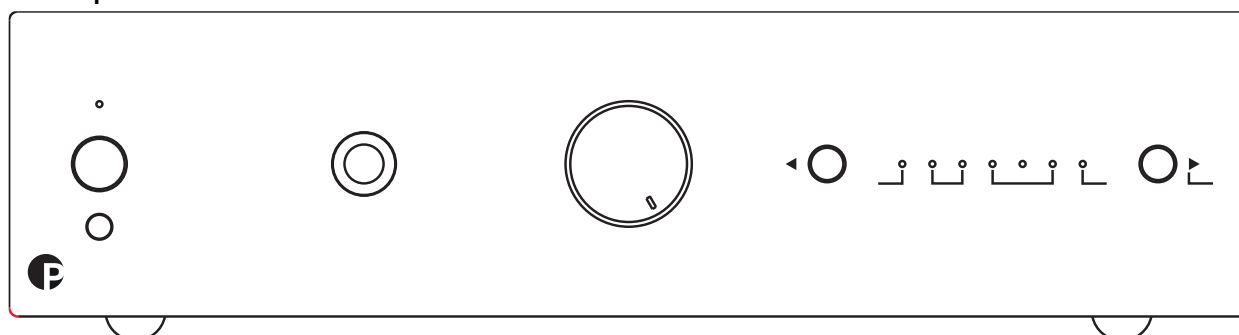


You can use the included USB C to USB A adapter to use USB A power cables that are commonly included with many products.

Mains power connection

Connect the low voltage plug from the power supply to the **Power 20V DC** socket of the amplifier before connecting the power supply to the mains.

Front panel controls



To switch on from standby or to standby

The push button on the left side of the front panel turns the unit on or back into standby. The blue LED above the stand-by push button shows that the unit is switched on.

Input selector

Press the push button next to the 7 input LEDs to switch between the inputs. Selected input number will be illuminated.

Volume

Adjust the volume to the desired level, using the large knob on the front panel.

Connecting a headphone

Connect the headphones to the 1/4" (6,3mm Ø) jack socket on the front of the unit.

BT connection

The Bluetooth antenna comes pre-mounted on the Stereo Box E.

BT is active only when input 7 is selected. If you want to connect your device the first time activate the pairing mode by pressing and hold the button **Input** (pair) until LED 7 starts blinking. The Stereo Box E is now visible & ready to pair for 60 seconds.

Pairing with Android devices

Open **Settings** and turn on BT. Start a **Scan** for BT devices. Searched devices will show up. Tap on "**Stereo Box E**" and confirm the connection. When the connection was successful, the LED of Input 7 lights up continuously. Now you can play music from your Android device over Bluetooth to Stereo Box E.

BT pairing with Apple devices

Tap on **Settings** and turn on BT. Your device will automatically start searching for available devices. Tap on "**Stereo Box E**" and confirm the connection. When the connection was successful, the LED of Input 7 lights up continuously.



Stereo Box E can store up to 8 BT devices. If the memory is full, new connections will automatically replace the oldest connection. A new connection is only possible if the LED of BT input is blinking slowly (it indicates that no device is connected).

Remote control

Replacing batteries

Proceed as follows:

- Unlock and slide open the battery case cover
- Replace the battery.
Make sure the battery is the right way round!

- Close the battery case cover

Battery type: 2x AAA 1,5V
